VEHICLE GUIDELINES FOR JUNIOR TRAINING CAMPS

The ACA, Wausau Kayak/Canoe Corporation(WKCC), the coaches and organizing personnel are not legally responsible for junior athletes while they are driving to the camps or home from the camps or programs.

The ACA, WKCC, the coaches and organizing personnel will not be held responsible for participants during transportation to and from activities during the period of camp. A clear and specific beginning and ending for camps and other activities will be established and published.

During the period of the camp, if a junior is under 16 years of age, he must be driven by a coach or manager 21 years of age or older who has been approved and designated by the manager of the camp.

If a junior wants to take his or her personal car, provided he/she and the car are adequately covered by insurance, and he/she has a valid driver's license and written parental permission, he/she may do so after obtaining permission from the camp manager.

If a junior wants to ride in the vehicle of anyone under 21 years of age during free periods, he/she can do so only if his/her parents or guardian has listed the name of the person with whom he/she may ride on a Transportation Release Form. Specific permission must be obtained from the camp manager.
